He briefed Donala earlier today. Mr. Gratrix spoke of 2 options. Option 1: 41 homes, and remaining space will go into highly restricted conservation easement. Letter proposes option 2: 56 homes, and remaining space would be gifted to GCA, no restrictions. Donala will need to make a decision on number of homes it is able to supply with water. Ken feels the HOA Board should consider which of the two plans we support. Donala will render a decision on the third Thursday of January.
